# **Camp rules**

Once in the camp, our dear quests agree to abide by its rules.

#### 1. General rules

- 1. Rules and regulations in the camp are issued in order to protect the interest of all guests (further in the text: campers).
- 2. This List of regulations underlines the campers' obligations while enjoying the accommodation services of the camp, as well as the instructions for the use of camp's devices and equipment.
- 3. Tourist campsite "Mina" is intended only for campers.
- 4. It is forbidden to take photos or videos of other campers without their permission.

#### 2. Check in, check out and payment

- 1. Upon the arrival, the campers are obliged to check-in at the reception desk. In order to check-in the personal documents of all campers are requested (ID or passport).
- 2. Check-in as well as check-out is available during the working hours of the reception seen at the reception. Otherwise, one more day will be included in the price.
- 3. The payment, in cash or by credit card is at the reception desk. It is suggested to make the payment one day before the departure, because of the possible waiting at the reception.

## 3. Public peace and order

- 1. Campers are obliged to abide by the public peace and order of the camp. Daily rest is from 13:00 till 15:00, and the night rest from 23:00 till 06:00 h.
- 2. During the rest it is not allowed to make any noise, to turn on the radio or tv, to sing or to use any musical instrument. It is suggested not to use motor vehicles if it is not necessary. The maximum speed of vehicles in the camp is 20 km/h and the traffic regulations must be obeyed. Pedestrians have the precedence over drivers.
- 3. The management of the camp has the right to cancel the accommodation services to those who violate public peace and order and disrupt the peace of other campers.

# 4. Use of the camping places

- 1. Pitches for camping equipment and vehicles are allocated by the campsite reception depending on the places available within the campsite.
- 2. The campers are not allowed to change their camping plots without the prior permission of the campsite reception service.
- 3. The campers are obliged to maintain their camping plots clean during their stay. Before departure, campers are obliged to clean their pitch and leave it in primordial state.

### 5. Use of equipment and devices

- 1. The campers may use the electric and public devices, and equipment in the correct manner and for the purpose they were intended.
- 2. Dish and laundry washing is only permitted in the designated areas.
- 3. Wash basins, sinks, showers, pissoirs and toilets must be used in the proper way, according to their designated purpose, taking into account that the sanitary facilities are for the common use of all campers.

# 6. Other rules

- 1. According to the Republic of Croatia's Act on fire-protection, in order to implement the safety of campers, it is forbidden to grill over open fires (wood or carbon)
- 2. Dogs must be kept on a leash and under the owner's surveillance while in the campsite.
- 3. All campers must register in the Guest book and they will be given a ticket, that must be exposed in a visible place during their stay.
- 4. The campers are obliged to maintain their place clean.
- 5. Rubbish must be placed in plastic bags and not be left outside bins placed around the campsite.
- 6. It is forbidden to cut down trees or to damage them (hammer the nails) or cut branches away.
- 7. The campers are responsible for safeguarding their property and belongings. The campsite management is not responsible for any loss or damage to belongings in the property of its campers, or for accidents or injuries in which occur at the campsite due to the negligence of the guest himself, nor is it responsible for damage caused by poor weather conditions or circumstances out of its control.

The camper is obliged to respect the Rules and regulations of the campsite; otherwise the campsite management has the right to refuse hospitality on the same and, if necessary, charge the camper for damage.
